## What will be your responsibilities?

### As a key member of the legal team, you will:

### Company secretarial:

Responsibilities of the legal counsel include:

- the design and implementation of all necessary policies and procedures to ensure that the company complies with its articles of association and its regulatory obligations and in particular those governing its operation as a listed company on Euronext and NYSE;
- keeping records required by statute to ensure that the company and its subsidiaries conduct their business in a legal and proper manner;
- assisting with the organisation of the annual shareholders' meeting, as well as any other special or extraordinary shareholders' meetings of the company and its subsidiaries;
- the organisation of the meetings of the board of directors in the subsidiaries;
- general corporate administration of group companies (following mandates of directors, required annual approvals, ...);
- Issuing advisory reports to the subsidiaries, pointing out missing steps towards legal compliance and giving support to realize them;
- aim to assure that the company, its officers and employees are informed of and comply with these laws, internal rules and ethical standards.



### Legal

Focusing on the legal side, you will:

- act as a contact person for all legal matters assigned by the Secretary General and/or the General Counsel for the various departments within the organisation;
- conduct research and/or provide legal analysis on legislative matters;
- assist in resolving legal issues and respond, if necessary, by drafting and submitting applications, complaints or protests on an extra judicial basis;
- generally to attend to all corporate and business law issues.
